ANITA SINGH**, daughter of Sri Dinanath Singh, aged about 40 years, by faith - Hindu, by occupation - Business, residing at 212D, Shibpur Road, P.S. - Shibpur, Howrah - 711102, (W.B.) in India, (3) **MRS. MAMTA SINGH**, daughter of Sri Dinanath Singh, aged about 34 years, by faith - Hindu, by occupation - Business, residing at 212D, Shibpur Road, 37, Howrah Municipal Corp, Shibpur, P.S. - Shibpur, Howrah - 711102, (W.B.) in India, all are Indian Citizen, hereinafter collectively called and referred to as the "**TRUSTEES**" which expression shall unless excluded by or repugnant to the context be deemed to mean and include the trustees for the time being of these presents and /or survivor or survivors of any of them and their successor or successors-in-office) of the **OTHER PART**.

WHEREAS the **SETTLOR** is desirous of creating an endowment by setting apart and establishing a fund for the Public Religious and Charitable objects and purposes in India hereinafter expressed.

AND WHEREAS the **TRUSTEES** herein have at the request of the **SETTLOR** agreed to act as **TRUSTEES** of these present upon the terms and provisions hereinafter expressed.

NOW THIS INDENTURE WITNESSTH AS FOLLOWS:-

01. In order to effectuate the said object of creating and establishing a Public Charitable Trust, the **SETTLOR** have delivered to and made over to the **TRUSTEES** a sum of Rs. 1,00,000/- (Rupees One Lakh) only with intent to part with all his right, title and interest claim therein, and vest the same in the

TRUSTEES to have and to hold the same and the investment or investments for the time being representing the same and all other properties that may for the time being represent the trust estate together with all additions and accretions thereto and all accumulated income thereof, and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the Trust (hereinafter referred to as the **TRUST FUND**) for the charitable objects and purposes and use hereinafter expressed with powers and on the terms and conditions herein contained of and concerning the same.

02. The name of the Trust shall be "**SMT. BIMLA DEVI AND SR. BHRIGU NATH SINGH EDUCATIONAL TRUST**", a Public Charitable Trust and the office of the Trust shall be at 40, Dharamdas Kundu Lane, P.S. - Shibpur, in the District of Howrah, Pin. - 711102, in the State of West Bengal (India), and Village- Hudhudipur, Post- Seorhi, District- Chandauli, Pin code- 232109, U.P. which may be shifted from time to time to such other place or places all over India as the Trustees may deem fit and proper at their discretion.

03. **The main objects and purposes of the Trust shall be :-**

- a) To improve the educational status of people by organizing various type of educational programme.
- b) To establish, maintain and run one educational Board for Secondary & Higher Secondary education as per guide line and educational policy of State and Central Government, Ministry of education, Ministry of HRD, etc.
- c) To establish and maintain academic professional and/ or Vocational Practical Courses under and in guide line of the board of U.P., C.B.S.C. and/or I.C.S.E or any other Higher Secondary Board Universities for the purpose of Monetary, Primary, Madyhamick, Secondary and Higher Secondary or higher education like B.A., B.Com, B.Sc. and M.A., M.Com, M.Sc. on different stream, under the approved syllabus with the view to provide the facilities of taking proper education to the people by the qualified teachers.
- d) To impart, promote and spread education in Arts, Science, Commerce and all other fields of education to the subjects of the Union of India and for the said

purpose to arrange for and take all the necessary steps as may be required including arranging for admission of Educational Institutions abroad and if possible stayal thereat.

- e) To hold examinations and to grant certificates of proficiency or other academic distinctions or title to persons who have complied with the conditions laid down in the regulations or byc-laws of the Trust and/or the State/Central Government or any other statutory body set up by such Governments.
- f) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, colour, race, creed or sex.
- g) To render sincere and efficient services to the students of the institution and to improve the standard of teaching and learning of the institution.
- h) To establish and maintain library for the benefit of public as well as students for their studies and to maintain reading rooms for readers including students and members of association and to make available arrangement for reading news paper, periodicals, books and journals;
- i) To equip the library with modern gadgets like computer with internet facilities and to provide service to make the library a center of special interest of students.
- j) To undertake and conduct training programmes including educational and vocational training leading to formation of new occupational skills, financial literacy, culture and aesthetic developments.
- k) To establish, provide, maintain and conduct or otherwise subsidise research laboratories and experimental work-shops for scientific and technical research and experiments and undertake and carry on with all scientific and technical researches, experiments and tests of all kinds and to promote studies and research, both scientific and technical investigations or inventions by providing, subsidising,

endowing or assisting laboratories, workshops, libraries, lectures meetings and conferences and by providing for the remuneration of scientific or technical professors or teachers and by providing for the award of exhibitions, scholarships, prize and grants to students or otherwise and generally to encourage, promote and reward studies, researches, investigations, experiment, test invention of any kind.

- l) To undertake, aid, sponsor, promote and co-ordinate the opening, organizing of educational institutions including school, college and any Institute of Research in anywhere of India as per demand of community people with proper permission/approval of the concerning authorities.
- m) To give education to the students through Bengali/Hindi/ English medium by the qualified teacher and to render services to the students on their education.
- n) To arrange and provide education to the intending students and to do and undertake all and whatsoever that may be required and/or necessary for the same.
- o) For the purpose as aforesaid to found, maintain, organize, run, manage, supervise, superintend, co-ordinate, affiliate, control, guide and aid schools, colleges, universities, Hostels, Boarding - houses, Laboratories, Exhibitions, Libraries, Lecture - halls, Practical Classes and other educational institutions and obtain affiliation with Indian/ Foreign University or Universities.
- p) Advancement, Promotion and spread of education, science, art, literature and the establishment, maintenance and support of college, schools, educational institutions, hostels, libraries, reading rooms or other educational institutions, providing grant, aids, (financial or otherwise), donations, loans, scholarships, fees and prizes.
- q) To open, establish, promote, set-up, run maintain, assists, finance, support and/or aid or help in the setting up and/or maintaining and/or running Junior Basic Training Education Center, B.Ed. Education College, Law College and others vocational Education Institution arid Management Institutions, Medical

- r) To establish and run Hospital, Holiday Home, Old age Home, Home for destitute, Adult Education Center, Library, Literacy Centers, Hospital Medical Care Center, Charitable Dispensaries etc.
- s) To grant relief at the time of natural calamity and disaster as and when felt necessary and also to grant stipend, scholarships to deserving students, Research scholars and workers for promoting the cause/causes of Literature Science, Technology, Culture and on the promotion of Human Resource Development.
- t) Medical relief and/or maintenance of the sick and/or establishment, maintenance and support of or donations to one or more hospitals, dispensaries, nursing homes, medical center and utilisations of funds for medical relief of all kinds.
- u) Relief to the poor including grants and aids (financial or otherwise) or persons stricken with calamities such as earthquakes, floods, droughts, famines, fire and riots.
- v) Relief and help to the aged, blind, lame, deaf, dumb, orphans and persons otherwise disabled or incapable of earning their livelihood or any one or more of them by grants and aids (financial or otherwise) and/or maintenance establishment and support of institutions and homes for the benefit of such persons.
- w) To undertake, carry out, promote, establish set up conduct aid help or otherwise support sponsor rural development and uplift including any programs for promoting the social and economic welfare of, or the uplift of the public in any rural and to incur expenditure on any program of rural development and to assist aid help execution and promotion thereof either directly or through an independent agency or in any other manner.

04. PROVIDED :

i) That the income or the assets of the trust fund shall not be applied or transferred at any time in whole or in part for any purpose other than for the benefit of trust.

ii) That the Income or Assets of the Trust shall not applied or used for the benefit of the authors of the Trust, or any persons who make substantial contributions or donations to the Trust or any Trustees or member of this Trust.

iii) That the Trust so created is irrevocable.

PROVIDED FURTHER that the objects of this trust shall always be in consonance or in conformity with such object as would be considered charitable in nature under the law of the country including the tax laws, applicable to charitable trusts for the time being, so that it may not lose its character of charitable nature as defined or laid down in any such laws and in particular under the Indian Income-Tax Act as amended from time to time.

05. The Trustees collectively shall be deemed to constitute the Board of Trustees. The Board of Trustees shall be consisted of :

06. The financial year of the trust shall end on 31st March, every year provided that the Board of Trustees shall be at liberty to change the same from time to time if it so deem fit and proper. The accounts will be audited every year after closing the financial year. But the quarterly inspection of the accounts is to be done and presented before the Trustees or Trustee if it is requested for.

06(a). The area of operation of the Trust is the whole of India.

07. The **TRUSTEES** shall from time to time after meeting the expenses of and incidental to the management of the Trust properties and of the Trust decide the

particular object or objects for which the income or corpus of the TRUST FUND or Properties for the time being available shall be applied.

08. The TRUSTEES may accept any donations or contributions in cash or in kind from any person, firm, company, corporation, association, institution or from another trust (including the settler or the trustees or any of them) for the furtherance of the objects of the Trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the Trust. The TRUSTEES may also take over the management of any other charitable or public institutions on such terms as they think fit and may manage such institution.

09. Without affecting the generality of powers and functions of the TRUSTEES of the manage and administer the Trust, the board of TRUSTEES shall have the following functions.

(a) To borrow if needed against the security of the asset of the Trust by way of bank overdrafts, loan or otherwise, as may be necessary for the benefit of the Trust and for more effectively carrying out the subject of the Trust provided the trustees unanimously agree on such borrowings and limited to the terms of their decisions or agreement and to authorize one of the Trustees to execute such documents, deeds, papers etc, as may be necessary in connection therewith.

(b) To arrange for and or authorize the signing or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the TRUSTEES by and one of the TRUSTEES to be nominated in this by the board of TRUSTEES and to make the same effective and binding as if the said agreement, contract, instruments or document or paper or writing were signed by all the TRUSTEES.

(c) To appoint or make provision for the appointment of a sub-committee of the TRUSTEES and or other to attend to or supervise or conduct specified jobs or functions or trust matter in such manner and subject to such rules and regulations as the TRUSTEES may prescribe.

(d) To authorize any one or more **TRUSTEES** to hold any property or any fund or any investment of the trust subject to the terms of these present in such manner and subject to such terms and conditions, rules and regulations as the board of **TRUSTEES** may from time to time think fit and proper.

(e) To spend any portion of the corpus or the income of the Trust fund for purchasing any land or constructing any building or buildings for and in the name of the Trust for the purpose of the carrying out promoting and or executing any or all the objects of the Trust.

10. The **TRUSTEES** shall cause true and accurate accounts to be kept of all money received and spent and for all matter in respect thereof in course of management of trust properties or in relation to carrying out of the objects and purposes of the trust as well as of all the assets, credits and affect of the trust properties.

11. The **TRUSTEES** may invest the trust Estate either in the purchase or immovable properties or of mortgage of immovable properties or in such manner as allowed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investment from time to time provided that such investment shall not be made which are directly or indirectly for the benefit or the any person referred in the sub section (3) of section (13) of the income tax act 1961, or any subsequent amendments as may be made from time to time.

12. If the income of the Trust property in particular years is not fully utilized, the unexpanded income subject to the applicable provisions of the income tax act 1961 shall be carried over to the next year or years and spent in subsequent year or years for the advancement of any of the objects of the Trust.

13. The Trust shall be at liberty to sell such portion or portions of the immovable movable properties forming part of the Trust estate either by public auctions or by private contract at such price or prices and or such terms and conditions relating to the title or otherwise in all respect as they may in their absolute discretion think fit and to rescind or vary any contract for the sale thereof and to resell the same without being answerable for any loss occasioned and to

execute all conveyance thereby or other assurance and to pass valid and effectual receipts and discharge for all moneys received by them.

14. The **TRUSTEES** shall keep an account or accounts with any bank or banks, or operate such account or accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the operation of such account or accounts and to authorize by appropriate resolution any two of the three (Chairman, Secretary, and Treasure) as available at the of operation of the account.

15. The Trustees may pay all charges and outgoings payable in respect of any immovable property for the time being forming part of the **TRUST FUND**, and may carry out repairs required to be done to the same and keep the same insured against loss or damage by fire and may incur all other costs, charges and expenses incidental to the administration and management of the Trust Estate and the properties for the time being belonging to the Trust as they may in their absolute discretion think fit.

16. The Trustees may manage or supervise the management of any land or lands, and premises for the time being comprised in the Trust Estate or any parts thereof erect, pull down, re-build, add to, alter and repair houses and other buildings and to build drains and make roads and fences and otherwise to improve and to cultivate or causes to be cultivated all or any of the said lands, and premises and to insure houses and buildings against loss or damage by fire and or other risks or to let, lease, make allowance to arrange with tenants, agriculturists, and generally to deal with the said lands, and premises as they may deem fit in their absolute discretion.

17. The **TRUTEES** may appoint Secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineers, Surveyors, Gomas, Service Provider or other employees (Agent and Business Associate) on salary / target/ commission basis for the purpose of management and supervision of the Trust Estate, for collection of rents, effect and profits, for keeping the account and for records and for other purpose of the Trust in addition to, the Trust pay leadership commission, gift or provide rewards/bonus as part of recognition of any achievement to Members and Non Members.

18. The Trustees may establish their office at such place or places and may change such places from time to time as they may think fit. The Trust may go for Joint Venture, Collaboration, and Amalgamation with any our NGO, Trust Company or Firm of national and international level.

19. The Trustees may demise the immovable property or properties for the time being and from time to time belonging to the Trust either from year to years or on monthly tenancies at such rent and subjects to such covenants and conditions as they may think proper and accepts surrenders of lease and tenancies and generally manage the same in such manner as they think proper.

20. The Trustees shall have full power of compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the Trust Estate and or the Trust properties and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and or the Trust properties and to do all other acts and things fully and effectually without being liable or answerable for any bonafide loss occasioned thereby.

21. The Trustees may join, cooperate, and amalgamate the Trusts created by these presents or any portion thereof with any Trust or and for managing the affair of the Trust or Institution having allied and or similar objects upon such terms as they may in their absolute discretion think fit.

22. The TRUSTEES may from time to time frame schemes and rules and regulations to carry out the object of the Trust and for managing the affairs of the Trust and otherwise for giving effect to the object and purposes of the Trust and to vary the same from time to time as the Trustees may in their discretion deem fit and proper.

23.
